Memorandum of Understanding (MOU)

THIS AGREEMENT is made on this 29 day of May, 2023

BETWEEN

SADHAN CHANDRA MAHAVIDYALAYA

Vill- Harindanga, PO- Chaberia, PS- Falta, South 24 Parganas, Pim-743504

WEST BENGAL, INDIA

AND

LALBABA COLLEGE

323, G.T. Road (Formally 117, G.T. Road), PO- Belurmath, Howrah- 711202, West Bengal.

Hereinafter individually referred to as "The Party" and jointly referred to as "The Parties":

DESIRING to engage in intercooperation between "The Parties" in Educational Exercises, Academic and Training Programmes and Research Activities, Library Activities and Office Activities.

PURSUANT to the prevailing laws and regulations, policies and procedures of India,

HAVE REACHED the following understanding:

Article 1

OBJECTIVE OF COOPERATION

The objective of this Memorandum of Understanding (MOU) is to cooperate each other in educational projects, Library Activities and Office Activities in areas of mutual interest.

Article 2

SCOPE OF COOPERATION

The Parties agree to implement co-operative programmes including but not limited to:

- a. Exchange of ideas of best practices regarding office management /teaching learning process of both the institutions.
- b. Faculty and student exchanges.
- c. Skill based certification / add on certification courses.
- d. Organizing seminars / webinars / conferences / symposia, etc.
- e. Access of students of both institutions to quality enhancement programmes organized at both the institutions.
- f. Undertaking Joint Research Programmes where possible.
- g. Academic and Administrative Audit (AAA)
- h. Exchange of ideas of best practices in the library, Collaborative collection development of e-resources on UG CBCS curricula and to give e-library services to internal and external library members through a commonly built in and shared database named WBCoLOR (West Bengal College Libraries' Online Resources), Share library e-resources and digital resources (Abiding INDIAN COPYRIGHT ACT 1957, SEC 52 - FOR ACADEMIC AND RESEARCH PURPOSE ONLY) either PDF or link to the original documents through WBCoLOR (<https://www.wbcolor.in>) , Organise Seminars, Webinars and Orientation programmes on library services under the co-ordinatorship of librarian/s.
- e. Any other Academic and Administrative Activities

Article 3

FINANCIAL ARRANGEMENT

Any cooperation under this MOU is subject to the availability of funding sources and approval of the relevant authorities. The minimum cost involved in maintaining the WBCoLOR database will be shared in equal amount by all the parties.

Article 4

LOCATION OF ACTIVITIES

1. The Parties agree to implement the programmes stated in Article 2 at Lalbaba College and Sadhan Chandra Mahavidyalaya.
2. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

Article 5

MODE OF CONDUCTING THE PROGRAMMES

The programmes will be conducted both on Online/Offline mode. Ample arrangements should also be made to conduct programmes in the Blended mode if required.

Article 6

DURATION AND TERMINATION

- 1) This MOU shall enter into force on the date of signing.
- 2) The MOU shall remain in force for a period of two (2) years and may be extended for another period of two (2) years by the mutual written consent of the Parties.
- 3) Either Party may terminate this MOU at any time by giving written notice to the other Party on its intention to terminate this MOU, at least six (6) months prior to the date of the termination.
- 4) The termination of this MOU shall not affect the completion of any project/s and programme/s in progress and not completed at the time of termination.

Article 7

AMENDMENT

- 1) This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MOU.


2) Such amendment/s or revision/s shall come into force on the date as may be determined by the Parties.
