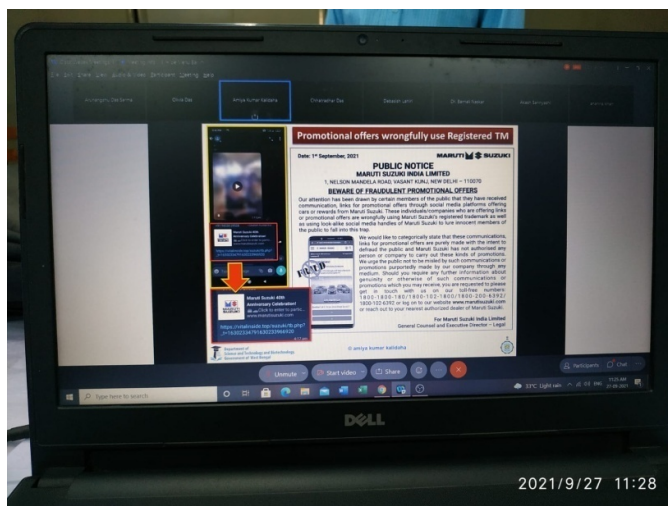

Lalbaba College Central Library in collaboration with IQAC, Lalbaba College organized a one day international level webinar on “**Intellectual Property Rights (IPR)**” on 27th September, 2021 via Cisco Webex platform. The webinar focused on the different aspects of Intellectual Property Rights. The programme started at 10:00 am with the welcome address by the Conveners Dr. Mala Aditya, the Librarian of Lalbaba College Central library and Dr. Barnali Naskar from the Dept. of Chemistry, Lalbaba College. The resource persons of the programme were Shri Amiya Kumar Kalidaha, Senior Scientific Officer in the Department of



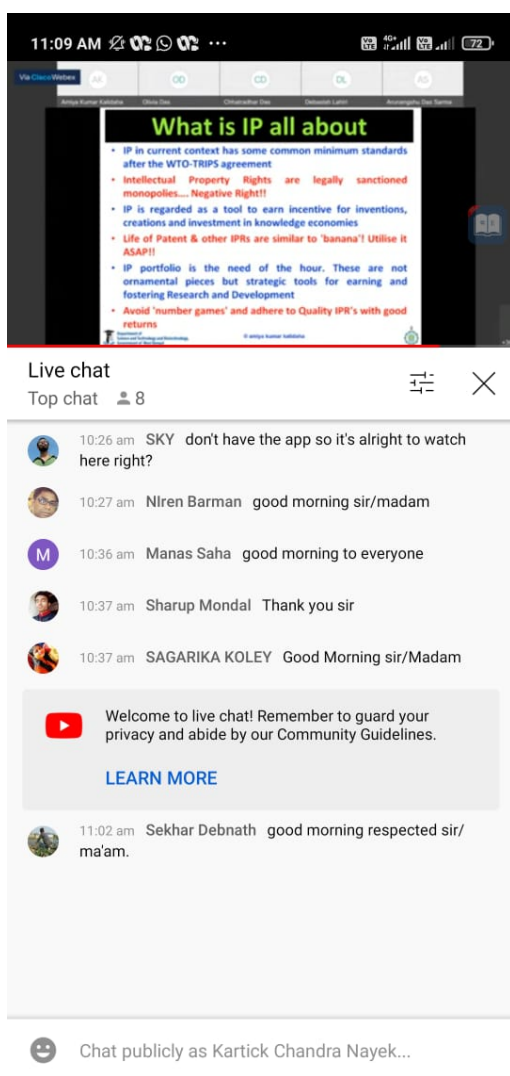
Science & Technology and Biotechnology, Government of West Bengal, Dr. Biswajit Pathak, Post Doctoral Research Scientist in University of Oxford, UK and Smt. Rajashree Venket Kundalia, Advocate of Calcutta High Court. The numbers of registered participants were 91.

Opening remarks and introduction of the programme was given by Dr. Sanjay Kumar, Principal of Lalbaba College. He welcomed all the resource persons and

talked about the importance of the knowledge on IPR for students, teachers as well as common people. Next, Dr. Chhatradhar Das, IQAC Co-ordinator also welcomed our resource persons and congratulated the members organizing committee of this webinar.

The first Speaker of the programme is Shri Amiya Kumar Kalidaha and he is the Senior Scientific Officer in the Department of Science & Technology and Biotechnology, Government of West Bengal. He gave a magnificent speech on the topic “**Basic concept of Intellectual Property and it's Rights**”. First of all, he clearly



explained about the different types of Intangible properties which are basically called Intellectual properties. He also emphasized that Intellectual Property is key aspect of economical development. The speaker elaborately explained about the different forms of Intellectual Property Rights in India such as Patents, Copyrights, Trademarks, Industrial designs etc. with various examples. Intellectual Property Rights are legally sanctioned monopolies. He further talked about the National strategy of Intellectual Property as well as criteria for IPR.

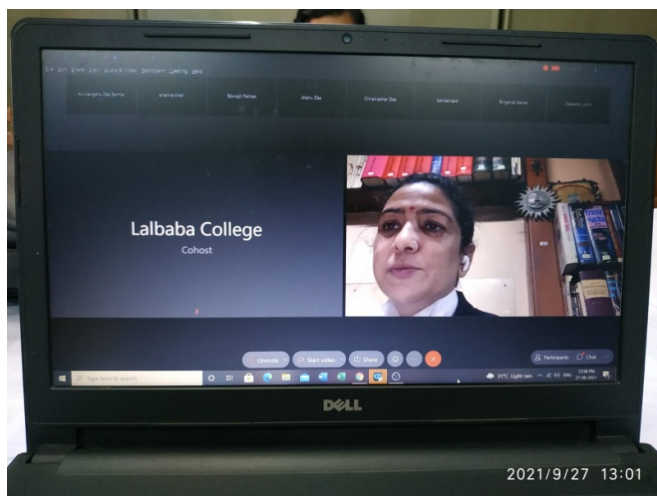
Next, Dr. Biswajit Pathak, Post Doctoral Research Scientist in University of Oxford talked on the topic-**Patent**. He started his presentation with the introduction to patents that a patent is legal protection which gives an inventor the right to exclude others from

performing certain activity in the country of issuance. He also talked about the criteria of a patent which are the invention should be novel, useful for society and

non-obvious. He also explained about the three types of patents such as Utility Patents, Design Patents and Plant Patents as well showed about the difference between a journal and a patent. Later he talked about the procedure of a Patent application. The PCT system is a Patent filing System which consists of international and national phase. He clearly explained about the timescales and activities of these phases with the example of a practical patent application. At last, he presented to the audience about different parts of patent application which mainly includes background of the invention, Drawing, description and claims.

The last speaker of programme Adv. Rajashree Venket Kundalia spoke on the topic : **Intellectual Property Rights: Legal review**. She broadly categorized the two aspects and remedies which are available widely known as civil and criminal remedies. Different Courts in India found that description is also an integral part of a



trademarks and hence if threatened, the actions for the passing off can be initiated. She explained in detail what are the detail actions can be taken against the violation of copyrights, trademarks, designs etc.

After completions of the three presentations, there was a wonderful interactive session where the audience interacted with the speakers clarifying their doubts and asking interesting questions.
