The selected agency shall deploy trained, disciplined, physically fit, properly uniformed, and police-verified security personnel for morning, day, and night shifts to ensure complete safety and security of the College campus, students, staff members, visitors, and all movable and immovable assets of the College. Interested bidders are requested to submit their sealed quotations by dropping the same in the Tender Drop Box kept in the Office of the Principal during office hours on all working days except Sundays and Government Holidays.

Terms and Conditions of Tender:

1. Scope of Work: The selected agency shall provide comprehensive security services, including but not limited to the following duties and responsibilities:

- Deployment of security guards for uninterrupted 24-hour security coverage on all days, including Sundays and Government Holidays.
- Deployment of two (02) properly uniformed and equipped male security personnel for active duty from 6:00 A.M. to 6:00 P.M. and one (01) dedicated Licensed Armed Guard/Gunman for night duty from 6:00 P.M. to 6:00 A.M.
- **Age of deployed Security personnel may not exceed 60 (sixty) years.**
- Protection and safeguarding of College property, classrooms, laboratories, offices, gates, and all campus premises.
- Opening and closing of classrooms, laboratories, offices, gates, and other facilities with proper handling of locks and keys strictly in accordance with directions issued by the College Authority.
- Regulation and monitoring of entry and exit of visitors, staff members, students, and vehicles within the College premises.
- Prevention of unauthorized entry, trespassing, theft, vandalism, misconduct, and other security-related threats.
- Maintenance of attendance registers, visitor registers, duty registers, log books, and incident reports.
- Assistance to the College Authority during examinations, academic programmes, cultural functions, emergencies, and official events.
- Adequate operational knowledge regarding fire extinguishers, electrical safety systems, medical emergencies, disaster management procedures, and other emergency response mechanisms.
- No leave shall be sanctioned to any deployed security personnel unless suitable reliever personnel are provided by the agency.



3. Eligibility Criteria for the Agencies/ Bidders: The bidder must fulfil the following eligibility conditions:

- Must possess valid registration, licence, and statutory authorization for providing security services under applicable laws.
- Must have a minimum of 2-3 years' experience in providing security services to Colleges, Universities, Government Institutions, or other reputed Educational Institutions.
- Must provide trained, disciplined, uniformed, medically fit, and police-verified security personnel.
- Must ensure strict compliance with all applicable Labour Laws, Minimum Wages Act, ESI, PF, Bonus, and other statutory obligations.

- Must possess valid GST Registration, PAN, and other mandatory statutory documents.

4. Liabilities of Agency/Bidder:

- All deployed security personnel shall maintain strict discipline, punctuality, proper uniform, and professional conduct within the College premises.
- The agency shall remain solely responsible for payment of wages, insurance coverage, statutory benefits, uniforms, supervision, and all liabilities relating to the deployed personnel.
- Replacement of any security personnel found unsuitable then will be replaced with permission by the College Authority.
- The initial contract period shall ordinarily be for Six (06) Months, extendable further subject to satisfactory performance and approval by the College Authority.
- The agency must submit Police Verification Reports (PVR) of all deployed security personnel prior to joining duty. Police Verification Reports shall also be submitted for all reliever or substitute personnel engaged subsequently.
- No cooking facility or cooking space shall be permitted within the College premises. However, the College may provide one room for use by the deployed security personnel during duty hours.
- In the event of any theft, damage, loss, or misappropriation of College property/assets caused due to negligence or failure of security services, excluding losses arising from natural disasters or force majeure conditions, the concerned agency shall be held responsible and liable for compensation/replacement of such loss in accordance with applicable Government Rules and Laws.
- Beyond the College hour, Security Guards will not be allowed to enter the college premises and must inform the College Authority.

5. Payment Terms:

- Monthly payment shall be made through Account Payee Cheque based on verified attendance records certified by the Field Supervisor and duly approved by the College Authority, subject to satisfactory performance of services.
- All statutory deductions, taxes, liabilities, and compliance obligations shall be borne entirely by the agency.

6. Documents to be Submitted: The bidder shall submit self-attested copies of the following documents along with the tender:

- Valid Agency Registration Certificate and Security Service Licence.
- Experience Certificates/Work Orders issued by Colleges, Universities, or Educational Institutions within West Bengal or India..
- GST Registration Certificate.
- PAN Card.
- Labour Licence and statutory compliance documents relating to ESI, PF, etc.
- Income Tax Return Acknowledgements for the last two financial years.
- Financial Bid in the prescribed format.
